- ➔ Is the highest decision-making power in the organization and is constituted from the Boards of directors and Board of executives.

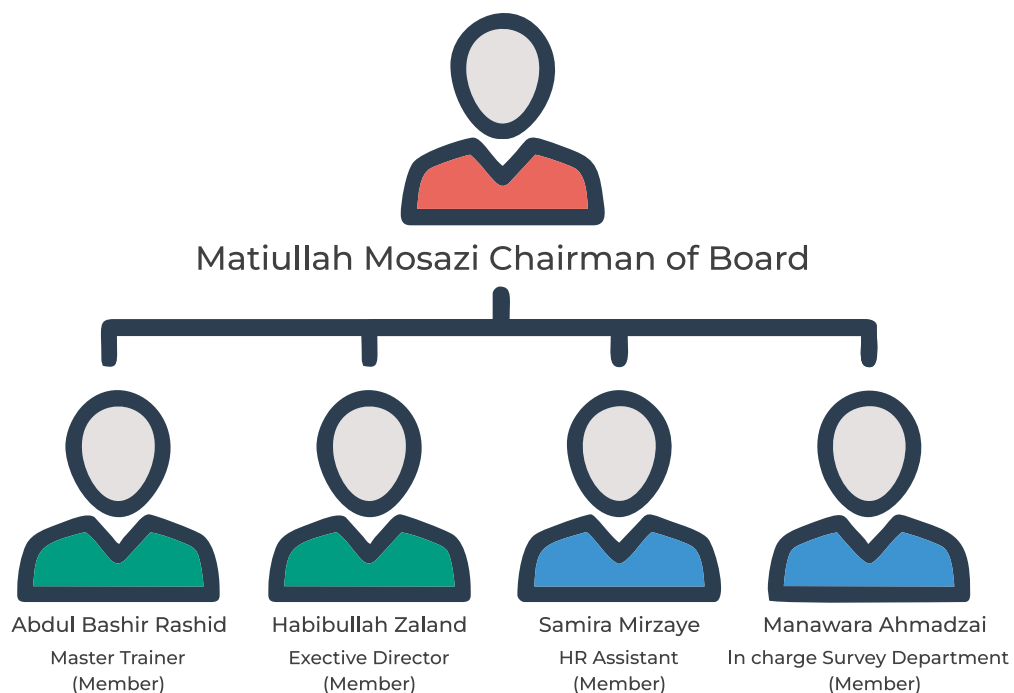


BOARD OF DIRECTORS OF HADAF:

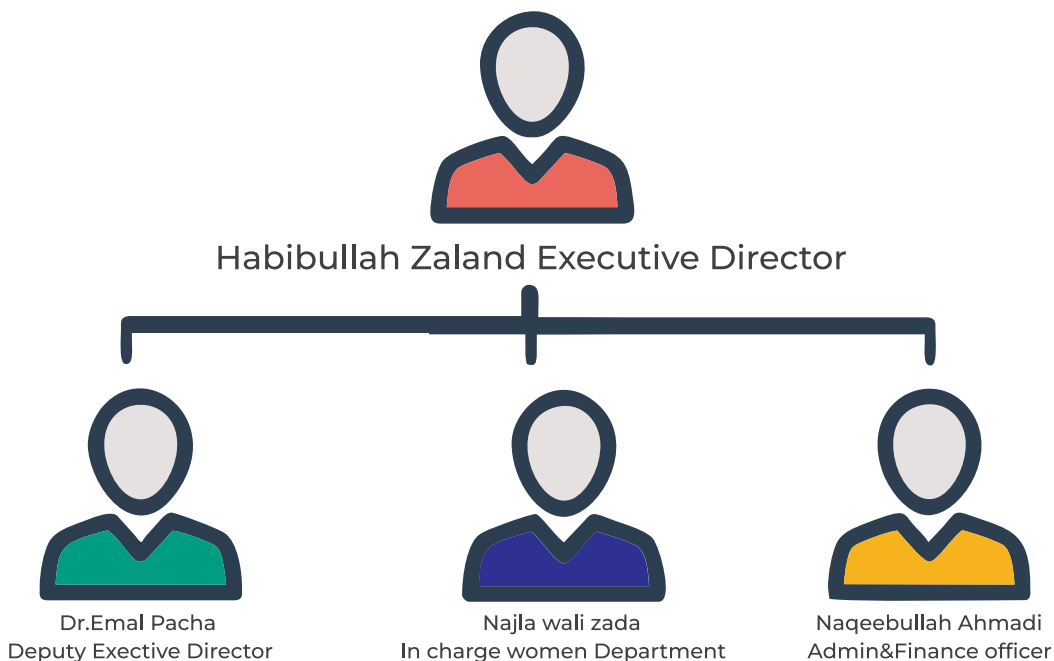


EXECUTIVE BOARD OF HADAF:

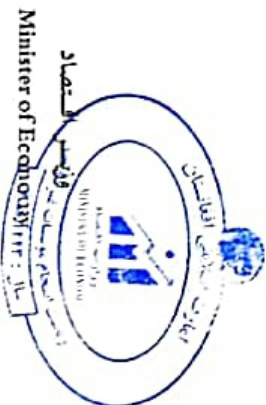
